Student Transportation Information

The Susquehanna Valley bus fleet transports approximately 1,400 students and travels approximately 350,000 miles each year. The transportation department employs approximately 25 staff members. In addition to four regular trips to and from each of SV's school buildings, the buses travel to other locations throughout Broome and Tioga Counties. There are also numerous athletic, educational, and music trips.

The first goal in the transportation of students is safety. Aboard the buses, students are expected to be well-behaved and to conduct themselves in an orderly, respectful manner. Students who choose not to follow the rules pose a serious threat to safety. Therefore, bus riding rules and regulations are strictly enforced. *Transportation is a privilege that can be revoked.*

The SV Board of Education has established a policy of transporting students to and from school which reduces the state mandated distance factor of two miles


for elementary students and three miles for secondary students. Children in the SV district are transported per the following schedule:

- Elementary students who live more than 1/2 mile from school;
- Students in grades 6-12 who live more than 3/4 mile from school;
- Students may be asked to walk these same distances to and from established bus stops.

Students who are transported to or from a location other than their home (babysitter's, child care center, relative's home, etc.) **must** fill out an Alternate Site Form each year.

Motor Vehicle Regulations

All persons who drive motor vehicles to or on school • property must comply with all the provisions of the



Motor Vehicle Law as well as those rules and regulations established by the Board of Education. Vehicle operators must strictly comply with all parking regulations, laws regarding the passing of stopped school buses, and the 10-mile-per-hour speed limit established on all district campuses.

All persons driving to the senior high school regularly must register their vehicle each year. Registration forms may be obtained at the SV High School Assistant Principal's Office.

Upon arrival at school, all vehicles should be locked. Students may park only in designated areas and once at school, students may not return to the vehicle without permission from the principal unless the student is leaving at the end of his or her school day.

All-terrain vehicles and snowmobiles are prohibited on school property.

Working Papers

SV issues working papers, as required by the NYS Department of Labor, to students under the age of eighteen living in the district. Please go to the SVHS Guidance Office, or the RTS Middle School Guidance Office, weekdays between the hours of 8:00 a.m. - 3:00 p.m. year-round to obtain the necessary forms.

Students wanting to secure working papers must:

- Pick up the Working Papers packet at the Guidance Office.
- Complete the Application for Employment and have it signed by a parent/guardian.

- Have the Physical Fitness Certification signed by your physician.
- Bring proof of age when turning in the completed forms.

Types of working papers available include:

- Newspaper Carrier Employment Certificate (ages 11-13)
- Non-Factory Employment Certificate (ages 14-15)
- Student General Employment Certificate (ages 16-17)



- Students must pass a physical examination given by the school physician, school nurse practitioner, or private physician. If a parent chooses to take a child to a private physician, the Health Appraisal Form can be downloaded from the Athletics page on the school website www.svsabers.org. Return the completed form to the middle school or high school nurse.
- Students may only start practice with a school athletic team once the above-mentioned items are completed and signed by the school physician.
- Students must maintain academic eligibility and be enrolled and participate in physical education to participate in interscholastic athletics.
- Students must abide by all rules and regulations in the Parent/Student

Athletic Handbook which can also be found on the SV Athletics website.



Clubs and Organizations

SV High School and RTS Middle School offer a variety of clubs and organizations to enhance the learning process. Most of these groups meet during Saber Time. Some of the clubs and organizations are: Drama Club, Honor Society (by selection), Mock Trial Team, Odyssey of the Mind, Intramurals, Peer Leadership, Ski Club,



French Club, Spanish Club, Student Council, Yearbook, Spirit Club, SADD (Students Against Destructive Decisions), Mathways to the Stars, Liberty Partnership, Book Club, SV Identity, and E-Sports.

The clubs and organizations change on a yearly basis depending on the interests of the students and faculty. Detailed information is available in the schools.

Library Media Centers

Students attending the Susquehanna Valley School District have the advantage of accessible and inviting Library Media Centers (LMC) in every school. The emphasis of the LMC is to create an environment conducive to locating, evaluating, and using information in all its forms and to encourage reading for pleasure for all students from kindergarten through twelfth grade. At the elementary level,

students come to the LMC once a cycle with their classes and are welcome to come in on an individual basis if they wish to borrow or return materials. Our elementary libraries are staffed by experienced Li-

brary Clerks. In secondary schools, the LMC is open all day for individual students as well as for curriculum related research projects involving entire classes. The high school and middle school libraries are managed by NYS certified School Librarians.

The habit of lifelong learning and a love of reading has always been promoted by our libraries and continues in this age of new tech-

nologies. The book and eBook collections are continuously updated based on student interests, reading levels, and curriculum needs.

Our school librarians ensure that our students are taught the current information

literacy, research, and evaluation skills

that will help them to succeed in college and careers. LMC computers give students access to a variety of databases, which provide accurate and up-to-date information. Remote access to the databases and eB-ook collection is available 24/7, year-round, from our school website. Ask your librarians for password information.





Music

Students attending the Susquehanna Valley School system have the opportunity to participate in a quality music program that includes courses in music appreciation and general music.

The vocal/choral program begins in our elementary schools with general music classes. At the middle school, students take general music in 6th and 7th grades, unless they are enrolled in an ensemble or

chorus. These classes introduce the recorder, guitar, singing, notation, and exposure to various music genres through band, orchestra, and choral literature. Additionally, students

have opportunities to participate in band, chorus, and orchestra ensembles.

The High School offers courses that are electives. Students may choose Band, Orchestra, Chorus, Music Theory, or Piano Lab to satisfy the requirements of one unit in music or art for graduation.

Instrumental lessons for strings, woodwinds, brass, and percussion are



started in grade 4. The middle school and high school have bands, orchestras, and choruses which are also an important part of the music program. Several concerts are performed

yearly throughout the district.

In addition to the band, orchestra, and chorus offerings, there are jazz ensembles in grades 6-12 and percussion ensemble in grades 9-12. Junior and senior music students are eligible to apply for and join Tri-M, a music honors society.



The SV School District is a member of the Broome County and New York State School Music Associations. Membership allows students to participate individually or as a unit at the All-County Elementary and Middle School festivals and sectional, state, and national events.

The music staff, administration, and students are proud of their achievements in competition and their service to school and community.



Support Services for Our Students

We set high standards for our students and we are able to assist them in achieving these levels. Learning does not come easily to everyone and we at Susquehanna Valley take our commitment to all children seriously. A number of services are available to help students achieve their educational goals.

Classroom teachers encourage students to seek assistance during the day or after class when necessary. A student's teacher is the first step in acquiring extra help. Intervention in mathematics, reading, and writing at both the elementary and secondary levels is provided through Academic Intervention Services (AIS). This is accomplished by small group instruction as well as


team teaching within the regular classroom. Students who score below state reference points on the standardized test and a local measure qualify for this support.

As a district SV embraces the fact that all students can and do learn in different ways while still being held to state standard expectations. When students' skills are below grade level expectations, support systems exist to help make a targeted plan for student skill growth. This process begins with a referral by a teacher and/or the parents to the building level intervention team. Using the Response to Intervention (RTI) model, this group of professionals will determine if there are instructional gaps and develop a targeted intervention plan to address the area of need.

After these techniques have been attempted and analyzed for growth, further assistance may be determined necessary and a written referral to the Committee on Special Education (CSE) may be



initiated with parental consent and support. The CSE consists of a parent, special educator, school psychologist, general educator and an administrator. This team works with the student's parents and classroom teacher(s) to determine if the child meets criteria for an educational

disability classification and the services that would most appropriately serve the child's needs. There are several programming, accommodation, and modification options within our district as well as through BOCES.

An Individual Education Program (IEP) or 504 Accommodation Plan is

written for each student identified with a disability. Each plan includes long and short term goals for the improvement of educational skills. Annually, the CSE will review the educational program of each special education student to determine its effectiveness and plan for the following year.

Responsibility for education lies with parents, the school district, and ultimately - the student. Each person learns in a different way and at a different pace. For some, this doesn't pose any difficulty, but for others, special support is necessary to ensure learning. Susquehanna Valley provides that support effectively.

Reporting/Promotion Policies

At the elementary level, a comprehensive reporting system is used to keep parents informed regarding their child's achievement. A combination of this reporting system, teacher input and evaluation and assessment, and administrative review are all integral components used in assessing the needs to promote or reassign a student. In addition to academic criteria, the school looks at a student's physical, emotional, and social maturity, as well as school attendance records, before recommending placement. Procedures enable the parents and teachers to work cooperatively toward providing a quality education for each child.

Report Cards for students in UPK through grade five are issued three times per year. Opportunities are provided for each classroom teacher to meet with each parent at least once during the school year. Parent/ teacher conference days are scheduled each school year.

At the secondary level, grades 6-12, the school staff provides parents with a clear understanding of each child's progress on a continuous basis. Report cards are issued at ten-week intervals. Students receive numerical grades, which can be weighted for class ranking purposes.

Between report card periods, interim reports are issued usually at five-week intervals and will be mailed home. Parents/Guardians of students in grades 6-12 may additionally use School Tool's Parent Portal, on the district website, to access their child's grades, assignments, absences, and other important information. Many of our staff members will contact parents by telephone to keep them informed of their child's progress. Parents are encouraged to phone for appointments with teachers if they need information or have questions about their child's school work. Parents are also encouraged to provide their child's teachers and school offices with valid email addresses to facilitate communication.






The Susquehanna Valley Central School District *A Brief History*

The consolidation of the Susquehanna Valley School District was completed in 1950. The district encompasses 57 square miles and contains approximately 15,000 residents. The district includes most of the Town of Binghamton, all of the Town of Conklin, a significant portion of the Town of Kirkwood, and small sections of both the Town of Vestal and the Town of Windsor.

Prior to the consolidation of the district, students were taught in one and two-room schoolhouses. After the passage of the State Education Reorganization Plan, these facilities were replaced and the Susquehanna Valley Central School District was born. Brookside Elementary in the Town

of Binghamton was built in 1958. That same year, Cedarhurst Elementary was constructed in the Town of Kirkwood (an addition was added in 1966). The Francis P. Donnelly Elementary School in Conklin, named for the district's first Superintendent, opened in 1964 and was completely renovated in 1991. Cedarhurst was closed as a school building in 2006.

Our two remaining elementary schools house



students in grades Pre-K-5. Students from grades 6-8 attend the Richard T. Stank Middle School, which opened in 1966. Susquehanna Valley High School, educating students in grades 9-12, was originally opened in 1958. The first completely "in-house" classes of K-12 were taught during the 1961-1962 school year and the class of 1962 was the first to complete 13 years of education entirely within the district.

Presently, the district accommodates approximately 1,800 students and staff. Capital projects approved by voters in 1998, 2008, 2013, 2016, and 2022 have enabled significant improvements and modernization of our facilities, including the district's first-ever swimming

pool, a synthetic turf multi-purpose stadium field, additional classrooms, a new state-of-the-art high school library/media center, technology upgrades, updates to electrical, heating and ventilation systems, roof replacements, access control and monitoring upgrades, a new buildings and grounds maintenance

facility and concessions stand, a new bus storage facility at Brookside, improved handicapped accessibility, districtwide window replacements, upgrades to the original house lighting system in the high school auditorium, replacement of student lockers and much more. Our most recent project involves extensive elementary classroom renovations, significant security upgrades, and considerable site reconfigurations.

District Staff Information

Approximately one hundred thirty teachers serve the district at the elementary and secondary levels. Additionally, professional support services are provided by psychologists, speech therapists, occupational therapists, physical therapists, school counselors, social workers, school nurses, library media specialists, and library clerks.



The support staff consists of custodial workers, secretaries, cafeteria workers, business office personnel, bus drivers, mechanics, aides, and specially assigned individuals.

The goal of all personnel is to provide students with the best possible education in surroundings that are safe and conducive to learning.





Attendance

We realize that some absences are unavoidable due to health problems or other circumstances. But, we also know that when students miss too much school, regardless of the reason, it can cause them to fall behind academically. Absences can add up quickly. A child is chronically absent if he or she misses just two days every month. Research shows that:


- Children chronically absent in Kindergarten and first grade are much less likely to read at grade level by the end of third grade.
- By sixth grade, chronic absence is a proven early warning sign for students at risk of dropping out of school.
- By ninth grade, good attendance can better predict graduation rates than eighth grade test scores.

We don't want your child to fall behind in school and feel discouraged. Please ensure that your child attends school every day and arrives on time. Here are a few practical tips to help support regular attendance:

- Make sure your child (even teenage children) keeps a regular bedtime and establishes a morning routine.
- Do not allow electronics in children's bedrooms.
- Pack backpacks and lay out clothes the night before.
- Do not allow children to take "mental health days" as a reason for staying home.
- Avoid scheduling vacations or doctor's appointments when school is session.
- Talk to teachers and counselors for advice if your child feels anxious about going to school.
- Develop back-up plans for getting to school if something comes up. Call on a family member, neighbor, or another parent to take your child to school.

Our established policy provides strict definitions regarding your child's school attendance:

Scheduled Instruction: Every period that a student is scheduled to attend instructional or supervised activities during a school day during the year.



Absent: The student is not present for scheduled instruction. *Tardy:* The student arrives after the scheduled instruction is designated to begin.

Early Departure: The student leaves before the end of the student's scheduled instruction.

Excused: Any absence, tardiness, or early departure for which the student has a valid school-approved excuse. These may be due to personal illness, medical appointments, illness or death in the family, religious observance, impassable roads due to inclement weather, quarantine, required court appearance, approved college visits, military obligations, approved cooperative work programs, or school-approved music lessons.

Unexcused: Any absence, tardiness, or early departure



for which the student has no valid school-approved excuse.

Register of Attendance: Any written or electronic record maintained to record the attendance, absence, tardiness, or early departure of a student.

For students in UPK through grade 5, a student's daily presence or absence shall be recorded once per day. For students in grades 6-12, a student's presence or absence will be recorded in each period of scheduled instruction. Late arrivals and early departures will also be recorded.

Attendance will *not* be used as a measure of student learning. Course credit is recommended based on student performance related to learning outcomes.

Parent/Guardian Responsibilities

A written excuse is required for EACH absence/tardy/ early dismissal from school within 48 hours of return to school. Parents/guardians are encouraged to contact



the Health Office in the building in which the student attends if their child is absent. This excuse must include a statement of the date(s) and reason(s) for the child's absence or tardiness. A written excuse - in and of itself - does not define excused or unexcused.

Incentives/Sanctions/ Notification of Parents

The district will communicate with parents/guardians regarding student attendance and tardiness. Progressive disciplinary consequences for unexcused tardiness will be imposed. Parents will be notified of these consequences. The district's Student Attendance Officer will collaborate with the administration to investigate attendance concerns and counseling will be made available to students with chronic attendance problems.

Summaries of the district's attendance policy are distributed to parents at the beginning of each school year. Each teacher will receive copies of the policy annually. Copies of the entire policy will be made available to community members upon request.

SV High School Curriculum

Susquehanna Valley High School strives to develop a curriculum designed to prepare students for college and career readiness. We are working to develop our students' problem-solving and teamwork skills necessary for success in life. Whether students elect to enter the workforce or to pursue further education upon graduation, we are continually developing a curriculum that is designed to meet individual and community needs.

Susquehanna Valley is developing stronger school-to-career connections by integrating work

experiences into our curriculum. Each vear we have students who attain Youth Apprenticeship experiences attending classes for half the day and reporting to the worksite for the remainder of the school day. Not only do these students earn money for their work, but they also earn credits for their apprenticeship, which benefits the business for which


they work. We also have a Workforce Wednesday program where we invite local employers and businesses to interact with students, providing them with valuable insights



into various career paths and the skills necessary for successful employment. This initiative not only

educates students about job opportunities but can also lead to employment or internship opportunities. In looking at ways to develop additional opportunities for students, we will also have our 24-25 Leadership Cohort, which focuses on skill building, resume building, and creating a personal vision.

We also have seniors participating in the New Visions Academy. These students gain valuable experience in engineering, health care, law and government, education, and business while working for local organizations. This

Susquehanna Valley Senior High School has introduced

program, with a continued focus on STEM (Science, Technology, Engineering, and Mathematics). Drawing for Design and Production (DDP) is an introductory course focused on technical drawing basics leading to design and building. Beginning with DDP, there are numerous half-year courses tailored to specific engineering interests. Students analyze issues and technologies to formulate opinions, make decisions, create solutions, and gain experience applying a variety of technological principles and concepts. For students interested in digital product design and rapid prototyping using Computer-Aided Design (CAD), we now have a 3-D Printing class. In our Fabrication class, students interested in the complex craft of building with natural resources, Compression/Tension Structures using different forces, Bridges, and Propulsion can utilize their skills, knowledge, and creativity in topics that include sustainability, ergonomics, transportation, and energy. For our Circuits class, students are

utilizing Arduino Model kits to become proficient in entrylevel coding and the creation of logic-based electronic programming. Students will hone their problem-solving and creative solution-building skills. Our competitive and award-winning Robotics course is designed to present students with specific complex tasks that they develop, design, digitally program (code), and build robotic solutions for. The 2024-25 curriculum has an exciting new drone component with multimedia capabilities. Lastly, our Hydroponics course combines current technological issues, food production, and their impact on our society. Students will evaluate current food production processes and design systems that incorporate alternative farming strategies to increase food production in modern soil-less methods.

Susquehanna Valley also offers a series of rigorous challenges designed to prepare students for the country's best postsecondary institutions. Our students may currently take Advanced Placement courses in Physics, Chemistry, American History, Global History, English, and Calculus. Students may also take college-level courses in English, Mathematics, Art, Physical Education, History, Language and Music through SUNY-Broome and Tompkins Cortland Community Colleges at no cost. We have recently added new courses in Programming and Coding, Theater, and Entrepreneurship, while we always are looking to add others in the future.

A major emphasis of our high school is developing a safe, student-centered learning environment. Our guidance staff, teachers, and administration strive to develop an atmosphere of mutual respect, positive self-esteem, and responsible citizenship. We encourage our students to participate in clubs and activities while contributing to our community's welfare. With this goal in mind, we offer a variety of programs to develop the skills and habits necessary to cultivate a well-educated and contributing student body.



Richard T. Stank Middle School Curriculum

Susquehanna Valley's Richard T. Stank Middle School is organized as a grade 6-8 building serving a population of approximately 325 students. The school offers a quality program of instructional and co-curricular activities designed to meet the unique physical, emotional, social, and intellectual needs of the adolescent.

The middle school programs serve as a "bridge" between elementary school and high school, helping our students develop skills for their continued success academically and beyond. Students at Richard T. Stank



Middle School are organized into interdisciplinary teams at each grade level.

At the sixth grade level, the interdisciplinary team teachers teach ELA, Math, Science, and Social Studies. At the seventh and eighth grade levels, the interdisciplinary team teachers provide instruction in ELA, Math, Science, and Social Studies. Depending upon grade level, students also receive instruction in Art, Music, Health, Family and Consumer Science,





Technology, and World Languages. All students participate in Physical

> Education classes. Interdisciplinary teaming at the middle school allows our teachers to organize instruction in a more meaningful fashion, helping in the transition to ninth grade and high school coursework. As required by the

Board of Regents' Action Plan, opportunities exist

for selected

students to be recommended for an accelerated program in Math and/or Science. During their sixth grade year, students will select one language to study in seventh and eighth grade. By completing French or Spanish in seventh and eighth grades, and passing the local final assessment, students earn a high school credit of World Language.

At the beginning of each school year, all students and parents are provided with information regarding







middle school programs. You are encouraged to review this information at the beginning of the school year and contact the appropriate office at RTS Middle

School if you have any questions.

Elementary Curriculum

Brookside and Francis P. Donnelly Elementary Schools provide a quality education for students in UPK through grade 5. The goal of our elementary schools is to provide a sound foundation of academic and social skills to prepare students for their middle and high school years. An outstanding array of professionals provide instruction in literacy, numeracy, science, social studies, technology, physical education, library, art, and music.

An ambitious testing and reporting program enables parents to be continually informed regarding student progress during the elementary years. The elementary schools also provide numerous activities both during and after school hours.

Parents are encouraged to join and support the PTA in each school.

Early Childhood Education

Susquehanna Valley will register children for Universal Pre-Kindergarten (UPK) who will be four (4) years of age prior to December 1 of the current school year and will register children for Kindergarten who will be five (5) years of age prior to December 1 of the current school year. If the number of registrants for UPK exceeds the number of allotted spaces, a lottery will be held to admit children into UPK spots.

At both the UPK and Kindergarten levels, a screening tool helps to determine cognitive, social, emotional and physical readiness of each student. Susquehanna Valley uses the Brigance screening tool for all incoming UPK students and the Gessell Screening tool for all incoming kindergarten students. Each is a direct observation tool used to measure children's physical/neurological growth, language skills, personal-social maturity, and overall adaptive behavior. They evaluate the behavioral responses of children according to age-related norms. The determined Developmental Age helps educators and parents to know where a child is in relation to typical growth patterns.

Universal Pre-Kindergarten (UPK)

Susquehanna Valley implemented our first full day UPK program in the 2017-18 school year. There are four UPK classrooms; two at Brookside and two at F. P. Donnelly;

each classroom is staffed with one teacher and one teacher aide. Both classrooms will have a maximum capacity of eighteen (18) students. Transportation will follow the current elementary bus run schedules.

Kindergarten

The main academic focus of Kindergarten is to prepare your child with the many skills that are needed to become successful in first grade. These skills will include the subject areas of Mathematics, English Language Arts, Science, and Social Studies.

Preparing your child for school

- Encourage play with other children the same age
- Assign small jobs around the house
- Ask him/her to identify colors, shapes and letters
- Help him/her to count and sort objects while touching them
- Read to him/her every day
- Listen to his/her stories and ask questions
- Help him/her to develop large motor skills by climbing, running, skipping, kicking, throwing, and catching.
- Assist in small motor development by providing opportunities for coloring, cutting, drawing and using Play-Doh, typing and buttoning.
- Talk about the school day and routines for getting on and off the bus

Child Nutrition

The Susquehanna Valley CSD recognizes the correlation between good nutrition and the ability to learn, and provides a nutritional food service program based on the USDA Dietary Guideline for all students.

For the 2024-2025 school year, all school meals, breakfast, and lunch, will be FREE TO ALL STUDENTS!

SV is implementing a meal certification option available to schools participating in the National School Lunch and School Breakfast Programs for 2024-2025, which means all students at Brookside and F.P. Donnelly Elementary, Richard T. Stank Middle School and Susquehanna Valley High School are eligible to receive a healthy breakfast and lunch at school at no charge each day of the 2024-2025 school year. For parents, no further action is required. There's no fee, nor is there a need to fill out and submit an application. We are so pleased to be able to offer this to our Sabers families in 2024-25!



School Year

Section 3604 of the New York State Education Law states that "...the board of education for the preceding school year shall show that the public schools were actually in session in the district...for not less than one hundred eighty (180) days."

Emergency Closings

When it is necessary to close the district schools because of an emergency such as very poor weather or building problems, notification efforts begin promptly. Official announcements are furnished to local media as early as possible.

Announcements will also be made directly to parents, students, and staff using an emergency telephone-based notification system. When schools are closed because of poor weather or for other reasons, they may also be closed for any other uses that might have been planned for that day such as athletic contests, drama, or music productions. Reports of these closings or cancellations will be given to the media as far in advance as possible.

The district requests that parents and students not call schools and the district offices during emergencies.

The Susquehanna Valley Central School District app is now available for all devices. The app enables parents, students, faculty, and staff to stay connected and informed about what's happening at Susquehanna Valley. Administrators can easily promote unified messaging through cross platform communications to the app, via push notifications. The Susquehanna Valley Central School District app is free and provides parents with quick access to everything school-related including calendars, directions to events, important documents, cafeteria menus, and more. Visitor Procedures

Visitors are welcome in the Susquehanna Valley School District. Each of our school buildings is equipped with an

access control system. Every visitor to our buildings must have a photo ID to pick



ARD asked to follow these procedures:

When visiting a school: Go to the Main Office entrance of

the school, push the button on the access

control system, identify yourself, sign in and obtain a pass. Please obtain permission if you expect to visit a specific area of the building.

When requesting early dismissal: Send a written request with your child. If you are to pick up your child, report first to the Main Office of the school.

Conduct and Discipline

The district believes that each student can reasonably be expected to be responsible for his/her behavior. The school administration assists each student in this program of personal responsibility with rules of conduct (focusing on safety and respect for the rights and property of others) that are consistently applied in classrooms and throughout each school. Students who cannot accept this responsibility and violate school rules may be penalized and may require additional supervision.

All of our schools provide information detailing rules of conduct through assemblies and written materials, such as student handbooks. Copies may be obtained by contacting the schools' main offices.

In compliance with New York Education Law's *Dignity for All Students Act (DASA)*, effective July 1, 2012, the Board has adopted an updated School District Code of Conduct and Discipline and revisions to the following policies:

#3420 - Non-Discrimination and Anti-Harassment in the School District;

#7310 - School Conduct and Discipline;

#7315 - Computer Usage and Internet Safety; and

#7552 - Bullying: Peer Abuse in the Schools

The Board has also approved the appointment of our school social workers as Dignity Act Coordinators in each school building.

Board policy, including the complete District Code of Conduct, can be found on the district's website: www.svsabers.org.

Information about DASA and the Code of Conduct will be distributed to parents at the start of school.

Emergency Contact Procedures

In the event of an accident, first aid is administered immediately and every effort is made to contact the family. If the family cannot be reached, the family physician is called. If the family physician is unavailable the district will make whatever arrangements are necessary to care for the injured student.

The success of this procedure depends upon accurate and up to date information. If you have not filled out an Emergency Information Card, or if there has been a recent change in a home or business phone number or a change in family physician, please notify the appropriate school.

* IMPORTANT: Per Public Health Law 2164, Section 66-1-4, there is a 14-day grace period from the start of school to obtain required immunizations. The student may attend school during the 14-day grace period. After the 14 day grace period, the student may NOT attend school until acceptable proof of immunization is received. Medication Administration in the School Setting

Any medication administered by the school nurse must be accompanied by an approved district medication form signed by both parent/guardian and provider. Additionally, all medication must be brought to school by a parent or guardian. Prescription medications

must be in the container dispensed from the pharmacy with the proper label. Overthe-counter medications must be in the original unopened container labeled with the student's name. Medications should not be

transported daily to and from school. It is recommended that parents ask the pharmacist for two containers: one to remain at home and one at school. Medications are stored in the Health office unless the provider deems the student capable of self carry/self administration. This MUST be indicated on the medication order form. No medication will be dispensed without proper forms and/or labeling. The school nurse cannot administer any over the counter medication without physician's order and parental permission. **Medication Forms may be obtained from the School Health Office or the district web site.**

Getting Involved

Parents and other residents have always played a significant and responsible part in the educational programs at Susquehanna Valley. This participation has been through membership in the PTA, participation on special purpose citizens committees sanctioned by

the district, by being elected to serve on the Board of Education and in numerous other ways.

This grassroots support, along with the efforts of the professional staff, has contributed strength and quality to the district's programs.



Board of Education

The Susquehanna Valley Board of Education establishes policies and adopts regulations for the conduct of the public schools. Its seven members, who serve without pay, are elected by the qualified voters of the district.

Responsibility for administering Board of Education policies is vested in the Superintendent of Schools.


SV Board of Education meetings are held at 6:00 p.m. on the third Wednesday of each month. District residents are welcome and encouraged to attend.
