ASSISTANT SUPERINTENDENT'S REPORT – Mrs. Brubaker announced that she has recruited a group of students to volunteer working at the Joint Dinner Meeting held on January 22, and thanked them in advance for their help. She reported that we received a grant through Pearson and the National Education Foundation worth \$14,500 that we will use for math software. She said that tomorrow she is heading to Binghamton University where she was asked to be a part of the Teaching and Learning and Educational Leadership Advisory Board. She said that we are trying to foster the relationship we have with them.

BOARD OF EDUCATION DEVELOPMENT REPORT - None

VOICE OF THE ADMINISTRATORS – Ms. Steward started by saying that they just wrapped up five weeks of the second quarter and sent out quarterly reports. She reported that the High School is in the spirit of giving supporting six families for Thanksgiving with dinners, and are currently doing the holiday gift drive. She said that several of the high school students went to the elementary buildings including Spanish IV and the football players to work with the younger students. She said that a group of seniors presented to Jason Garner in his Challenge for Change, a presentation about mental health awareness; they received \$500 from Mr. Garner for this. The High School is also having a Community Conversation about mental health on January 23, The whole community will be invited, and it is geared toward middle and high school students.

Ms. Rich reported that the first report cards have gone out followed by parent teacher conferences. She said that the Winter Concert took place last week and was very well attended; she thanked the PTA for providing refreshments. She said that both elementary buildings had their first round of Agriculture in the Classroom with Cornell Cooperative Extension, and this was a great hands on learning experience for them. They will be returning in February for their second round. Mrs. Brubaker announced that with Ms. Rich, Donnelly Elementary was awarded \$1400 to fund their One School One Book program.

Mr. Schuldt reported that the contractors would be working over the holiday break finishing up CIP work. He stated that the Smart Bonds was still under review and awaiting approval.
